- (4) We have satisfied ourselves about the capability of the underwriters to fulfil their underwriting commitments. **Noted for compliance.**
- (5) Written consent from the Promoters has been obtained for inclusion of their Equity Shares as part of the promoters' contribution subject to lock-in and the Equity Shares proposed to form part of the Promoters' contribution subject to lock-in, shall not be disposed or sold or transferred by the promoters during the period starting from the date of filing the DRHP with the SEBI until the date of commencement of lock-in period as stated in the DRHP. Complied with and noted for compliance.
- (6) All applicable provisions of the SEBI ICDR Regulations, which relates to Equity Shares ineligible for computation of Promoters' contribution, have been and shall be duly complied with and appropriate disclosures as to compliance with the said regulation(s) have been made in the DRHP. **Complied with and noted for compliance.**
- (7) All applicable provisions of the SEBI ICDR Regulations which relate to receipt of Promoters' contribution prior to opening of the Offer, shall be complied with. We confirm that arrangements have been made to ensure that Promoters' contribution shall be received at least one day before the opening of the Offer. We undertake that auditor's certificate to this effect shall be duly submitted to the SEBI. We further confirm that arrangements have been made to ensure that the Promoters' contribution will be kept in an escrow account with a scheduled commercial bank and shall be released to the Company along with the proceeds of the Offer. - (8) Necessary arrangements have been made to ensure that the monies received pursuant to the Offer are credited or transferred in a separate bank account as per the provisions of sub-section (3) of Section 40 of the Companies Act, 2013, as amended, and that such monies shall be released by the said bank only after permission is obtained from all the Stock Exchanges and that the agreement entered into between the Bankers to the Offer and the Company specifically contains this condition. **Noted for compliance.**
- (9) The existing business as well as any new business of the Company for which funds are being raised fall within the 'main objects' in the object clause of the Memorandum of Association of the Company or the

#### ANNEXURE III A

#### Note explaining the process of due diligence that has been exercised

In connection with the draft red herring prospectus dated August 16, 2024 ("DRHP"), we, the BRLMs, have undertaken due diligence exercise in relation to the Company and its Subsidiaries for the purposes of complying with the applicable provisions of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the "SEBI ICDR Regulations"), and other applicable laws, and to the extent that it is customary in initial public offerings in India, along with other professionals and experts engaged in connection with the Offer. All capitalized terms used herein and not specifically defined shall have the same meaning ascribed to such terms in the DRHP.

In connection to the Offer, Khaitan & Co has been appointed as the legal counsel to the Company as to Indian law, Trilegal has been appointed as the legal counsel to the BRLMs as to Indian law, and Latham & Watkins LLP has been appointed as the international legal counsel to the BRLMs (together, the "Legal Counsels"). The Legal Counsels have assisted in carrying out the documentary due diligence and drafting of the DRHP in compliance with the SEBI ICDR Regulations and advising the BRLMs and the Company on other legal matters related to the Offer, in their respective roles, and for the purposes of issuing legal opinions in relation to the Offer to the BRLMs.

The due diligence process commenced with physical and virtual interactions with the key managerial personnel, senior management of the Company, including the Managing Director, Whole-Time Director and Chief Executive Officer, Director – Finance & Commercial and Chief Financial Officer, and Company Secretary and Compliance Officer to gain an understanding of the business of the Company and its Subsidiaries, key risks involved and financial overview of the Company and its Subsidiaries, amongst other matters. These interactions were conducted with the objective of assisting the Company in preparing necessary disclosures as required under the SEBI ICDR Regulations and other applicable laws in relation to the Offer. In this regard, the Company was provided with a due diligence questionnaire and information list prepared in consultation with the Legal Counsels (defined below), and the Company provided supporting documents for review and diligence and gave clarifications and explanations for queries raised, to the extent applicable. In order to facilitate such review, the Company set-up an online data room where copies of such supporting documents were made available for undertaking due diligence.

In the due diligence process, apart from the Legal Counsels, the BRLMs were also assisted by the Statutory Auditors (defined below), the Independent Chartered Accountant (defined below), the Independent Chartered Engineers (defined below), the DPR Agency (defined below), Coal Consultant (defined below), Mining Geologist (defined below) and the Secretarial Auditor (defined below).

The BRLMs were also assisted by the statutory auditor of the Company, Deloitte Haskins & Sells LLP, Chartered Accountants (the "Statutory Auditors") for carrying out financial due diligence of the Company. In addition to providing the restated consolidated financial information and examination report thereon as at for the financial years ended March 31, 2024, March 31, 2023 and March 31, 2022, the Statutory Auditor has provided their



examination report dated August 12, 2024, a customary comfort letter to the BRLMs confirming the accuracy of the financial information contained in the DRHP, and a statement of special tax benefits available to the Company and its shareholders and has verified details and provided certifications in respect of certain other matters, *inter alia*, the computation of Company's net worth, operating profit/loss and net tangible assets to ascertain the eligibility of the Company to undertake the Offer, certificate on loan utilisation by the Company and other certifications with respect to financial information included in the DRHP.

Further, Shah Gupta & Co., Chartered Accountants ("Independent Chartered Accountant") assisted the BRLMs by verifying and providing certifications with respect to certain information included in the DRHP, including, without limitation, outstanding dues, related party transactions, contingent liabilities and tax litigation, remuneration of Directors, Key Managerial Personnel, and Senior Management, certifications on the weighted average cost of acquisition by the Promoters and Selling Shareholders for certain specified periods, average cost of acquisition of Equity Shares by the Promoters and Selling Shareholders, weighted average price at which Equity Shares were acquired by the Promoters and Selling Shareholders in the preceding one year, and weighted average price of Equity Shares and preference shares transacted in the last 3 years, 18 months and 1 year prior to the date of filing the DRHP of all shareholders, Company's ESOP schemes, certifying the key performance indicators included in the "Basis for Offer Price" section of the DRHP on page 157, compliance with the i) Securities and Exchange Board of India (Framework for Rejection of Draft Offer Documents) Order, 2012; (ii) Securities and Exchange Board of India (Issuing Observations on Draft Offer Documents Pending Regulatory Actions) Order, 2020 and (iii) Securities and Exchange Board of India Prohibition on Raising Further Capital from Public and Transfer of Securities of Suspended Companies) Order, 2015, and operational and other parameters disclosed in the DRHP.

The Statutory Auditors and the Independent Chartered Accountant have, each respectively, confirmed that as on the date of DRHP they hold valid peer review certificates issued by the peer review board of the Institute of Chartered Accountants of India. The Statutory Auditors and the Independent Chartered Accountant have, each respectively, also consented to be named as an 'expert' in the DRHP, in terms of the Companies Act, 2013 and such consent has not been withdrawn as at the date of filing the DRHP.

In relation to the project reports which have been obtained for the purposes of the Objects (defined below), Holtec Consulting Private Limited ("**DPR Agency**") has consented to include its name as an "expert" in respect of project report issued by them in relation to the Greenfield Integrated Unit at Nagaur, and such consent has not been withdrawn as on the date of this DRHP.

Dr. S.K Jain, practicing company secretary ("Secretarial Auditor"), have by way of his certificate dated August 16, 2024 confirmed (i) compliance of the employee stock option schemes of the Company, namely JSW Cement Limited Employee Stock Ownership Plan – 2016 and JSW Cement Limited Employee Stock Ownership Option Plan – 2021 with the Securities and Exchange Board of India (Share Based Employee Benefits and Sweat Equity) Regulations, 2021, to the extent applicable (ii) confirmed compliance with Chapter II and Chapter IV of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), and the Companies Act, 2013 with respect to the composition of the committees of the



board, and (iii) compliance with the Companies Act, 2013 with respect to issuance of securities since inception till the date of filing of Draft Red Herring Prospectus.

Further, we have obtained and relied on certifications provided by Kondru Dhanapathi Rao, duly qualified independent chartered engineer (the "Chartered Engineer"), Min Mec Consultancy Private Limited, independent coal consultant (the "Coal Consultant"), and Vallabh Tarun Chander, independent mining geologist (the "Mining Geologist"), for the diligence related to information pertaining to the installed capacity and capacity utilisation of facilities and mines operated by the Company and its Subsidiaries. The Chartered Engineer, Coal Consultant and Mining Geologist have consent to be named as "experts" in terms of the Companies Act, 2013 and such consents have not been withdrawn as at the date of filing the DRHP.

In addition to the above, the Independent Chartered Accountant, has provided a statement of special tax benefits available to the JSW Cement FZE ("Material Joint Venture"). We have also obtained an opinion from foreign counsel, being MAA & Partners which covers a broad overview of the business of the Material Joint Venture, regulatory framework with respect to the business, the corporate structure, the capital structure, and its shareholding pattern.

The Company has also placed reliance on the report titled "Market review of Cement Sector" dated July 2024 prepared by CRISIL MI & A, a division of CRISIL Limited ("CRISIL" and such report, the "CRISIL Report") for disclosures in relation to industry information in the DRHP. Further, the Company has received a written consent from CRISIL dated August 5, 2024, to include extracts of the CRISIL Report in the DRHP, Red Herring Prospectus and Prospectus. The CRISIL Report has been commissioned and paid for by the Company and has been prepared exclusively for the purposes of disclosures in inter alia the "Industry Overview", "Our Business", "Risk Factors" and "Management Discussion and Analysis" sections of the DRHP. Further, the Company has received a written consent from CRISIL dated August 5, 2024 to include the CRISIL Report in the DRHP and as a material document for inspection by the public in the section titled "Material Contracts and Documents for Inspection" of the DRHP.

#### 1. Business and commercial diligence

The due diligence process in relation to general business and commercial matters included:

(a) Organizing and attending a kick-off discussion, transaction related calls and virtual/in-person meetings with the management of the Company to develop an understanding of the business, history, and other matters of the Company and Subsidiaries, including the industry overview and the regulatory environment. The discussion was attended by Managing Director, Whole-Time Director and Chief Executive Officer, Director – Finance & Commercial and Chief Financial Officer, and Company Secretary and Compliance Officer and other representatives of the senior management of the Company, along with other members of the secretarial, legal and finance departments of the Company, Legal Counsels, BRLMs and the Statutory Auditors. A broad overview of the business of the Company and its subsidiaries and joint venture, industry



in which it operates, regulatory framework with respect to the business, the corporate structure, the capital structure, and financial statements and the shareholding pattern of the Company and details of the Promoters of the Company was given followed by interactive discussions.

- (b) Requesting the Company to provide relevant documents in the data room and/ or over e-mails and reviewing such documents along with the Legal Counsels, as is customary in such a transaction.
- Regularly interacting with the management team of the Company, including the Company Secretary and Compliance Officer and other senior personnel from the secretarial, legal and finance departments and the Statutory Auditor for the purpose of gaining an understanding of the business, the risks involved and a financial overview of the Company, among other matters. These interactions included (i) physical and virtual drafting sessions, due diligence calls and conference calls to discuss the disclosures in the DRHP; (ii) due diligence calls with the Statutory Auditors; (iii) due diligence calls with CRISIL and certain customers, (iv) seeking appropriate clarifications and certifications from the Company for key financial, operational data and other information (v) bring-down due diligence calls to receive updated information from the Company before filing the DRHP; and (vi) obtaining and relying on certificates, formal representations and undertakings from the Company, Subsidiaries, the Material Joint Venture, the Promoters, the Promoter Group, the Group Companies, the Directors, the Key Managerial Personnel and senior management of the Company, the Statutory Auditors, Independent Chartered Accountants, Chartered Engineer, Coal Consultant, Mining Geologist, DPR Agency, Secretarial Auditor and other documents, including the CRISIL Report, in support of certain disclosures made in the DRHP, including certain operational data included in the business section and for compliance with the SEBI ICDR Regulations. These interactions were conducted with an objective to assist the Company to prepare disclosures in the DRHP. The BRLMs shall undertake these interactions and due diligence calls until the allotment of Equity Shares in the Offer. Accordingly, disclosures in respect of the business carried out by the Company as well as associated risks in relation thereto, have been made in the sections titled "Our Business" and "Risk Factors", respectively, in the DRHP. We expect these interactions and due diligence calls to continue until completion of the Offer.
- (d) Conducting physical site visits, of (i) Nandyal (Andhra Pradesh); (ii) Nagaur (Rajasthan); (iii) Salboni (West Bengal); (iv) Vijaynagar (Karnataka); and (v) Dolvi (Maharashtra), which is vested with the Company and where the Company proposes to utilise the Net Proceeds towards part financing its cost of establishing a new integrated cement unit. We also undertook a site visit of the registered and corporate office of the Company, for our due diligence in order to understand the Company's day to day operations and key business processes.
- (e) Obtaining and relying on formal representations and undertakings from the Company in the Offer Agreement.

- Reviewing, together with the Legal Counsels, power purchase agreements, supply agreements, leave and license agreements, lease deeds, and other business-related documents, including among others, arrangements and documents executed by the Company with its customers on a sample basis. These sample documents were reviewed on the basis of the revenue contribution of such customers. Further, in addition to the foregoing purchase orders were reviewed for the products sold by the Company on a sample basis on the basis of sales made to the top customers of the Company. The DRHP includes the restated consolidated financial information which comprises the restated consolidated financial information of the Company and the Subsidiaries as at for the years ended March 31, 2024, March 31, 2023 and March 31, 2022, which comprises the restated consolidated statement of assets and liabilities as at, March 31, 2024, March 31, 2023 and March 31, 2022; the restated consolidated statement of profit and loss (including other comprehensive income); the restated consolidated statement of changes in equity, the restated consolidated statement of cash flow for the years ended March 31, 2024, March 31, 2023 and March 31, 2022.

The Statutory Auditors were required to review the financial information relating to the Company in the DRHP and has delivered a customary comfort letter and circle-ups confirming the accuracy of the financial information contained in the DRHP. Such comfort letters will be issued and/ or brought down at certain future dates as the Offer progresses.



Certifications have also been obtained from the Statutory Auditor in respect of financial matters pertaining to the Offer and the DRHP such as an eligibility certificate of the Company to undertake the Offer under Regulation 6(1) of the SEBI ICDR Regulations. The Statutory Auditors have provided a statement of special tax benefits available to the Company and its shareholders, and have verified details and provided certifications in respect of certain other matters, inter alia, the computation of Company's net worth, operating profit/loss and net tangible assets to ascertain the eligibility of the Company to undertake the Offer, compliance with corporate governance requirements and other certifications with respect to financial information included in the DRHP. In addition, the Independent Chartered Accountant, has verified and provided certifications in respect of certain other information included in the DRHP, including, but not limited to, certifications on the weighted average cost of acquisition by the Promoters and the Selling Shareholders for certain specified periods, average cost of acquisition of Equity Shares by the Promoters and the Selling Shareholders, weighted average price at which Equity Shares and preference shares were acquired by the Promoters and the Selling Shareholders in the preceding one year, and weighted average price of Equity Shares and preference shares transacted in the last 3 years, 18 months and 1 year prior to the date of filing the DRHP of all shareholders, Company's ESOP schemes and the Company's operational information, including, but not limited to, certifying the key performance indicators included in the "Basis for Offer Price" section of the DRHP on page 157, and operational and other parameters disclosed in the DRHP.

In addition to the above, as part of diligence, discussions were held with the management of the Company and the Statutory Auditor and reliance has been placed on explanations and representations provided by the management of the Company that all the related party transactions entered into for the periods disclosed in the DRHP have been entered into by the Company in accordance with applicable laws. Further, for this purpose, we have also obtained certification from the Independent Chartered Accountant.

In accordance with Schedule VI, Part A (11)(I)(A)(ii)(b) of the SEBI ICDR Regulations, the audited standalone financial statements of the Company, its subsidiary namely Shiva Cement Limited and its Material Joint Venture namely JSW Cement FZC (for the purposes of the SEBI ICDR Regulations via-a-vis upload of financial statements), for the financial years ended March 31, 2024, March 31, 2023, and March 31, 2022 shall be available at https://www.jswcement.in/.

Suitable disclosures have been made in relation to key performance indicators of the Company in the section "Basis for Offer Price" on page 157 of the DRHP and other relevant sections in the DRHP in compliance with the amendments to the SEBI ICDR Regulations dated November 21, 2022. Further, such key performance indicators ("KPIs") were approved by the Audit Committee of the Company pursuant to its resolution dated August 14, 2024 and such key performance indicators as disclosed in the DRHP have been certified by the Independent Chartered Accountant. The certificate issued by the Independent Chartered Accountant in relation to the KPIs will form part of the section "Material Contracts and Documents for Inspection" of the DRHP on page 702 and will be available for public inspection from the date of filing of the RHP with the RoC until the Bid/Offer Closing Date.



Further, as per the provisions of the SEBI ICDR Regulations, the Company is required to provide link of the website of the Group Companies of the Company where financial information of such Group Companies has been disclosed. Accordingly, the financial information of the top five Group Companies namely, JSW Steel Limited, JSW Energy Limited, JSW Infrastructure Limited, JSW Steel Coated Products Limited and JSW Steel Global Trade Pte. Ltd. have been disclosed on the website of the each of the respective Group Companies, except for JSW Steel Coated Products Limited and JSW Steel Global Trade Pte. In relation to the information disclosed in summarized form in the section "Financial Indebtedness" of the DRHP, the relevant sanction letters and agreements issued by the lenders as well as other financing related documents were made available and together with the Legal Counsels, the same were reviewed. The Company and its Subsidiaries have also received written consents from its lenders to the extent required, granting the Company their no-objection to undertake the Offer and related corporate actions including inter alia issue and allotment of the Equity Shares, change in the capital structure of the Company and change in the board of directors of the Company. The details of the outstanding borrowings availed by the Company and its Subsidiaries including certain key terms of such borrowings are disclosed in the section Financial Indebtedness of the DRHP. We have also relied on a certificate from the Independent Chartered Accountant to ascertain the amount of outstanding borrowings of the Company, on a consolidated basis, as of March 31, 2024, as disclosed in the section "Financial Indebtedness" of the DRHP.

# 4. Objects of the Offer

The Company proposes to utilize the Net Proceeds for (1) Part financing the cost of establishing a new integrated cement unit at Nagaur, Rajasthan, (2) for prepayment, in full or part, of certain borrowings availed by the Company, and (3) General corporate purposes (collectively, the "**Objects**").

In relation to the aforesaid proposed project, project report has been obtained from DPR Agency in relation to the cement unit at Nagaur, Rajasthan which also mention the break-up of estimated costs, applicable regulatory and government approvals required for the project. Further, quotations from various contractors, vendors and suppliers have also been obtained for the plant and machinery, fixed assets, civil works and structures. The applicable regulatory and government approvals for the aforesaid project have also been reviewed. The project report will form part of the section "Material Contracts and Documents for Inspection" on page 702 of the DRHP and will be available for public inspection from the date of filing of the RHP with the RoC until the Bid/ Issue Closing Date.

Further, the Statutory Auditors have certified the loans proposed to be prepaid have been utilized for the purposes for which they were availed.

Furthermore, the Company, its Subsidiaries, its Joint Venture, the Promoters, and the Directors have provided confirmations stating that they have not been debarred or prohibited from accessing the capital markets or from buying, selling or dealing in securities under any order or direction passed by the SEBI or any securities market regulator in any other jurisdiction or any other authority/ court. In addition, confirmations have been received from the Company, Promoters and Directors stating that they have not been categorized as wilful defaulters or fraudulent borrowers as per the definition in SEBI ICDR Regulations. Confirmations have also been received from the Company, the Promoters and the Directors that none of the Promoters or Directors of the Company are 'fugitive economic offenders' as per the definition in the SEBI ICDR Regulations.
