JSW CEMENT EXPANDS ITS FOOTPRINT WITH FORAY INTO NORTH INDIA

COMMENCES PRODUCTION AT NEW GREENFIELD INTEGRATED CEMENT PLANT AT NAGAUR, RAJASTHAN

TAKES ITS INSTALLED GRINDING CAPACITY TO 24.1 MTPA

Mumbai/Nagaur (Rajasthan), March 19, 2026: JSW Cement, one of India's leading green cement producers and part of the diversified JSW Group, today laid a significant milestone in its journey of national expansion, by commencing production at the state-of-the-art, greenfield, integrated cement manufacturing plant **in the district of Nagaur in Rajasthan – its first such facility in north India.**

With this foray into the northern region, the company's total cement grinding capacity stands at 24.1 MTPA and the total clinker manufacturing capacity (including the clinker capacity at the company's joint venture, JSW Cement FZC) stands at 9.74 MTPA.

The Nagaur integrated plant is equipped with a **3.30 MTPA clinkerisation unit** and a **2.50 MTPA cement grinding unit**. Further, an additional 1.00 MTPA cement grinding unit is under construction at this site. This strategically-located facility can cater to the high-growth markets in Rajasthan, Haryana, Punjab, and the National Capital Region (NCR).

The Nagaur unit has been funded through a strategic mix of equity and long-term debt. The company allocated ₹800 crore from the fresh issue proceeds of its Initial Public Offering (IPO) specifically towards part-financing of this unit.

Announcing this today, **Mr. Parth Jindal, Managing Director, JSW Cement**, said: *“The commencement of production at the Nagaur, Rajasthan facility is a pivotal moment for JSW Cement. Our aim, as outlined during our IPO process, was to put the company firmly on the path of becoming a pan-India player and with this commissioning the company enters the fast-growing Northern Indian market. We look forward to servicing the growing needs of the region and contributing to the economic growth of Rajasthan, Haryana, Punjab and the NCR area. I am truly excited that the company was able to commission this greenfield integrated unit within 21 months showcasing our project execution capabilities. With this commissioning, the company is firmly on track to achieve its 41.85MTPA capacity on or before FY29.”*



Mr. Nilesh Narwekar, CEO of JSW Cement, added: *“Foraying into the rapidly-growing north Indian market is a strategic priority for us. These states are witnessing some of the highest growth rates and massive infrastructure development. With the Nagaur facility, we aim to provide our customers with high-quality, eco-friendly cement and a world-class service experience, all the while maintaining our position as one of the world’s most sustainable cement producers. With this expansion, the company is also moving closer to its mid-term capacity target of 41.85 MTPA in India. and its long-term vision of achieving 60 MTPA capacity.”*

The plant is designed as a model of sustainable manufacturing. The facility includes provisions for the co-processing of alternative fuels in the kiln and a 7 km long Overland Belt Conveyor to transport limestone from the mines, thereby reducing the environmental impact of road transport. The world class plant will also soon feature a 16 MW Waste Heat Recovery System (WHRS) to capture and reuse heat from the production process, significantly reducing its carbon footprint.

About JSW Cement: *JSW Cement is part of the diversified JSW Group. As one of India’s leading business houses, JSW Group also has other business interests in sectors such as steel, energy, maritime infrastructure, defence, B2B ecommerce, realty, paints, sports and venture capital. JSW Cement is present across the entire value-chain of building materials comprising cement, ground granulated blast-furnace slag (GGBS), concrete and construction chemicals. This gives the company a unique advantage to cater to the diverse needs of the construction industry with its premium, high quality & eco-friendly products. The company utilises industrial by-products in the manufacture of cement, GGBS and other building materials thereby ensuring a greener future for the next generation.*

The Company’s operations currently include eight plants in India, which comprise one integrated unit, one clinker unit and six grinding units across the states of Andhra Pradesh (Nandyal plant), Karnataka (Vijayanagar plant), Tamil Nadu (Salem plant), Maharashtra (Dolvi plant), West Bengal (Salboni plant), Odisha (Jajpur plant, its subsidiary Shiva Cement Limited’s clinker unit and the Sambulpur grinding unit). The Company also operates a clinker unit through JSW Cement FZC, its joint venture in the UAE. Its business vision has been acknowledged through various awards including Iconic Brand of India (2023), CII ITC-Excellence Award in Corporate Social Responsibility (2023), International Green Apple Award (2023) among others.
